We are looking for an enthusiastic person who is committed to bringing high quality, place-based watershed exploration experiences to the youth of Salem and surrounding North Shore towns in Massachusetts. This is an opportunity to expand STEAM education and inspire curiosity and cultivate an understanding of human impact on our natural world.

Our School to Sea Program provides year-round programing with in-class, after school, boat trips, and summer camp opportunities for over 5,000 students across the North Shore. School to Sea covers topics related to marine science, environmental science, and climate resiliency. The School to Sea Director works closely with the Executive Director and Development Director and will be a member of a dynamic team.

Key Responsibilities:

- Leads programs on salt marsh science, coastal erosion, invasive species, watershed stewardship, local ecology, and more, that support teachers and provide memorable learning experiences for students.
- Works with administrators and teachers to align curriculum and build community relationships.
- Trains, supervises, and evaluates School to Sea educators and interns.
- Designs new curriculum for in- and out of school programs for pre-school through 8th grade.
- Creates, implements, and analyzes assessments for School to Sea programs.
- Works closely with the Executive and Development Directors and the SSCW team to ensure the success and growth of the School to Sea program by developing proposals and writing grants to procure funding for existing and new programs.
- Manages the School to Sea budget, invoicing, and grants.
- Writes an annual report to present the program's accomplishments and metrics
- Supports other SSCW programs and events

- Confidence and ability in teaching and leading engaging educational activities among learners of diverse backgrounds, ages, abilities, and group size
- Comfort in curriculum/lesson plan design and implementation, including familiarity with national and state frameworks and best practices
- Comfortable teaching in a variety of settings, including classrooms, public spaces, and the outdoors
- Experience managing risk and safety while working with youth in outdoor settings

- Ability to walk/stand for at least one hour and lift 25 pounds from ground level
- Ability to work independently and as part of a team in a fast-paced environment
- Willingness to be flexible, creative, and problem-solve on the fly
- Strong verbal, writing, and MS Office skills
- Bilingual (English, Spanish, Portuguese) applicants are encouraged to apply

Location: This position is based out of our office, 12 Federal Street, Salem MA.

Schedule: Full-time exempt (40 hours). This position requires occasional early morning, evening meetings, and weekend events. Most duties will be performed on-site at the SSCW office (in Salem, MA), at nearby schools, or public parks/conservation areas.
